Appropriate engineering controls

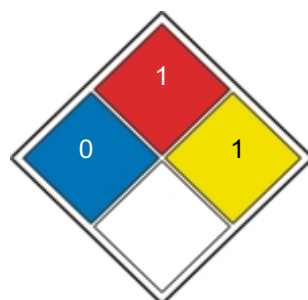
