8.2. Exposure controls**Appropriate engineering controls**

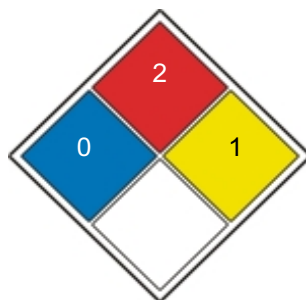
